We are looking for investors who share our vision and passion for creating a better future for Australian workers and businesses. The company will be replicating the SEEK's business model, offering lower prices, simplicity and efficiency. We are offering up to 50% of the company in exchange for raising an investment of \$75,000. This investment will help us scale up our development and secure on-time project delivery.

Goals

- Set and deploy the appropriate servers and technologies Enterprise Fiber to the building completed ensures a fixed cost even while growing the traffic load, Local Enterprise server structure completed ensures a fixed, controllable startup cost. Data Centre infrastructure 80% completed, better uninterrupted battery supply required at later stage. Approximate completion cost \$8,500 to be invested by VELEV PTY LTD.
- 2. Develop and deploy JobRush.com.au timeframe: by the end of October 2023. Fixed cost of development is \$150,000. Over 40% of the development is already completed by Velev PTY LTD and will be provided to the investment group as part of the 50% stake for Velev.

Details

An investment group to be created and given shares according to the investment portfolio. Maximum of 50% are offered to the fixed cost of \$75,000. After completion the project is deployed and future profits are split by agreement (TBA).

Ownership

Intellectual property to be owned by the investor group in accordance with the share split. The hardware is owned by Velev and provided to the investor group as part of the development for the next 24 months as it may need to be replaced / upgraded or relocated later, once the Jobrush.com.au grows.

Milestones

The following are the proposed milestones for the project of launching JobRush.com.au, a platform that connects job seekers and employers in Australia. The project is a joint venture between VELEV PTY LTD, a software development company, and an investment group.

I. Set and deploy the appropriate servers and technologies.

This milestone involves establishing the infrastructure for hosting and running the platform, as well as ensuring its security, scalability and reliability. The main components of this milestone are:

- Enterprise Fiber to the building 100% completed. This ensures a fixed cost even while growing the traffic load, as well as high-speed internet access and bandwidth.
- Local Enterprise server structure 100% completed. This ensures a fixed, controllable startup cost, as well as easy maintenance and customization of the servers.
- Data Centre infrastructure 80% completed. This involves setting up the hardware, software and network components for storing and processing the data of the platform. The remaining 20% of this milestone is to improve the uninterrupted battery supply for backup power in case of outages. The approximate completion cost of this milestone is \$8,500, which will be invested by VELEV PTY LTD.

II. Develop and deploy JobRush.com.au.

This milestone involves designing, coding, testing and launching the platform, as well as providing user support and feedback. The main components of this milestone are:

- User interface design in progress 100% completed. This involves creating the layout, graphics, colors and fonts of the platform, as well as ensuring its usability and accessibility.
- Backend development in progress 30% completed. This involves developing the logic, functionality and features of the platform, as well as integrating it with the servers and databases.
- Quality assurance in progress. This involves testing the platform for bugs, errors, performance and security issues, as well as fixing them before deployment.
- Deployment planned. This involves releasing the platform to the public domain, as well as monitoring its performance and user feedback.
- User support planned. This involves providing customer service, technical assistance and troubleshooting to the users of the platform, as well as collecting their suggestions and complaints.

The timeframe for completing this milestone is by the end of October 2023. The fixed cost of development is \$75,000, which will be paid to VELEV PTY LTD. VELEV PTY LTD will also provide the source code of the platform, which will be owned by the investment group. Velev has invested so far approx \$15,000 in hardware, servers and network components plus over 8 months (300+ hours) of planning, research, setup and development for JobRush.com.au with current development value over \$60,000.

III. Sell JobRush.com.au to a competitor like SEEK.com.au or another investor

Exit Intention statement / strategy - after a completion and successful deployment of the system a process of growing the business will be started and finished to a point where (**if agreed**) the system can be sold for an agreed sum, covering but not limited to the minimum of 10x of the initial investment.

Meanwhile profit proceeds will be split according to the shares owned in the investment group.
